FAIR WORK COMMISSION

DECLARATION UNDER REGULATION 126 OF THE FAIR WORK (REGISTERED ORGANISATIONS) REGULATIONS 2009

On the 03 January 2017 I, GEORGE BRADLEY TILBURY President of the Police Federation of Australia - Western Australia Police Branch (the Branch), 639 Murray Street WEST PERTH, state as follows:

1. I am an Officer of the Police Federation of Australia and authorised to make this Declaration.
2. The Branch have proposed a number of amendments to the registered Rules of the Police Federation of Australia Part CA – Western Australia Police Branch (ANNEXURE 1).
3. Rule 52AZ – Making or Alteration of Branch Rules empowers the Branch to add, amend, rescind or otherwise alter Branch Rules by resolution carried by a two-thirds majority of the Branch Executive, subject to Rule 34 – Branches sub rule (b) of the Federal Rules.
4. Federal Rule 34(b) provides “Branches may from time to time make Rules not inconsistent with these Rules, the Workplace Relations Act, or regulations made thereunder.” (ANNEXURE 2).
5. Under Rule 52AZ sub rule (2), written notice of a proposal to make amendments to the Rules is required to be provided to the Branch Executive Members, at least one month prior to the relevant meeting of the Branch Executive.
6. On 06 November 2016 I sent an email to Branch Executive Members containing a copy of the proposed amendments to the Rules and advice that the proposed Rule amendments would be discussed at the Branch Executive meeting to be held 16 December 2016 (ANNEXURE 3).
7. The Agenda for the 16 December 2016 meeting, noted at Item 8.1 the business of altering the Branch Rules (ANNEXURE 4).
8. Rule 52AZ sub rule (1) requires any resolution to add to, amend, rescind or otherwise alter Branch rules to be carried by a two-thirds majority of the Branch Executive.
9. On 16 December 2016 the Branch Executive Meeting was held, with a quorum of 13 Members, at which the proposed amendments were passed unanimously, thereby exceeding the prescribed two-thirds majority as detailed at Item 8.1 of the Branch Minutes (ANNEXURE 5).
10. The alterations were made in accordance with the Rules of the Organisation.

11. The Police Federation of Australia has published a notice on its website, a notice that particulars of an alteration to the rules has been lodged in the Fair Work Commission.

The particulars set out in this notice of alteration in respect to the nominated rule changes are true and correct to the best of my knowledge and belief.
