

**SUPPLEMENTARY DECLARATION OF AUTHORISED OFFICER in accordance with Regulation 126
*Fair Work (Registered Organisations) Regulations 2009***

I, Shane Prior of 217 North Quay, Brisbane in the State of Queensland, Branch President of the Queensland Police Branch of the Police Federation of Australia (PFA) declare:

- 1. I am authorised under the rules of the PFA to give this notice of particulars of alterations to the rules of the PFA and to make this declaration as required by Regulation 126 of the *Fair Work (Registered Organisations) Regulations 2009* (Cth).
- 2. On 5 November 2024, I caused to be lodged with the Fair Work Commission a declaration of myself being the notification of an alteration to the rules of the PFA required by section 159 of the *Fair Work (Registered Organisations) Act 2009* (Cth) (**Declaration**).
- 3. It has recently come to my attention that the Branch's lawyers inadvertently provided an earlier draft of 'SP1' and 'SP3' which were enclosures to my Declaration.
- 4. I am aware that 'SP2', being a copy of the notice I caused to be sent on 15 October 2024 to each member of the Branch Executive, is correct and contains the correct resolutions which were proposed to be passed on 23 October 2024.
- 5. 'SP2' and 'SP3' inadvertently did not include the following resolution, and the particulars of the rule alteration resulting from the following resolution:

insert a new rule 102 as follows:

102 – Transitional Rule (Election Cycle)

(a) For the purposes of this rule the words in column A have the meaning set out opposite in column B:



2021 Regional Representatives	<i>the Regional Representatives declared elected by the Australian Electoral Commission in Matter E2021/48</i>

- (b) The purpose of this rule is to correct the irregularity in relation to timing of the Quadrennial Election cycle for Branch Regional Representatives resulting from a delay in the conduct of an election conducted conduct by the Australian Electoral Commission in 2021.*
- (c) Despite sub-rule 40(g), the term of office for the 2021 Regional Representatives will conclude on 30 June 2025.*
- (d) Despite sub-rule (c), the 2021 Regional Representatives will hold their respective office until their successor is declared elected in an election held in 2025 under rule 40.*
- 6. The 'correct' particulars of the rule alterations are attached to this declaration marked as tracked amendments and annexed as 'SP4'.
- 7. The correct resolutions passed at the Branch Executive Meeting on 23 October 2024 are annexed and marked 'SP5'.
- 8. As the inclusion of rule 102 would amount to a truncation of office, the persons holding the offices effected by the truncation consented to the alteration prior to the resolution being considered by the Branch Executive on 23 October 2024.
- 9. Annexed and marked 'SP6' are the consents of the:
 - (a) Far Northern Branch Regional Representative;
 - (b) Central Regional Representative;
 - (c) Southern Regional Representative;
 - (d) Metropolitan North Regional Representative; and

(e) Headquarters and Support Regional Representative.

10. I declare:

- (a) that the alterations were made in accordance with the rules of the PFA as set out in the Declaration;
- (b) the action taken under the rules of the PFA to make the alterations is set out in the Declaration; and
- (c) that the particulars set out in this notice are true and correct to the best of my knowledge and belief.
